PART-TIME TIMETABLES

Are you aware of the guidance on part-time/reduced timetables?

Children and young people compulsory school age have a legal right to receive full-time educational provision, this should be suitable to their age, aptitude and any special educational needs they may have. Children and young people additional needs have the right to access the same opportunities and hours as their mainstream peers. The LA must be informed when implementing a part-time timetable, guidance on parttime tables is available Southwark Education website.

CENMAC

Assistive technology

CENMAC is made up of a team of specialists who support children and young people experiencing barriers to learning or communication to access the curriculum and to communicate using assistive technology. They provide a unique service offering assessments, reviews and the assistive technology augmentative and alternative communication (AAC). CENMAC support is available to children and young people aged 2 to 25 with Education Care Plans (EHCP) in education and special schools.

CHANGES TO STATUTORY FORMS

New forms for:

- Requesting an Education, Health and Care **Needs Assessment**
- Annual Review of an existing EHCP

On the 6th January 2025, new statutory forms will be released by Southwark SEN. The forms will be shared via email, along with associated guidance. They will also be available on the Southwark education website.

Please note that there will be two versions of each form - one is intended for the Early Years through to Year 4, the other from Year 5 onwards. It is expected that settings will use the new forms as soon as they become available. However, as schools may be currently completing some statutory processes, Southwark SEN will accept the current forms until March 7th 2025. After this date, any requests or annual reviews submitted with the old forms will be returned with a request to utilise the new paperwork.

EHCP Banding review
