#### >> Share your views about planned changes to DSL/DDSL training

You may be aware that Southwark's DSL/DDSL training is currently delivered by external trainers. From the Summer Term, this training will begin to be delivered inhouse by the Safeguarding in Schools team, with input from other Southwark teams and services as well as from partner agencies. We want to ensure the new training works for schools and provides the right foundation for the DSL/DDSL roles. #### >> Southwark School Immunisation Update

The Southwark Immunisation Team is currently delivering the seasonal influenza vaccination programme for:

- Primary school children (Reception to Year 6)
- Secondary school children (Year 7 to Year 11)

Routine vaccination uptake has declined, and London currently has the lowest vaccination rates in England, increasing the risk of flu outbreaks among children and young people. The influenza programme will end on 12 December 2025, so the immunisation team is asking for your support in this final push to improve uptake. To ensure all eligible pupils are offered the influenza vaccine, the immunisation team requires a class list for each year group if this has not already been provided.

How schools can help:

#### >> Unpacking Adultification Bias Course – Tuesday 2 December

As the designated and deputy designated safeguarding leads who attended our training courses know, the independent trainer and consultant Catherine Rushforth facilitates training for us. Catherine's training and consultancy company Catherine Rushforth and Associates is running in person Unpacking Adultification Bias Course on Tuesday 2 December, 9.30am to 4.30pm that may be of interest. The course is designed to inform, empower and mobilise practitioners and managers across a range of children's services. It is focused on recognising and naming Adultification Bias; understanding how harmful it is to the self-esteem, confidence and protection of brown, black and poor children; assuming professional responsibility to take action in preventing it – in line with safeguarding duties outlined in the current London Child Protection Procedures, Keeping Children Safe in Education 2025 and the Equality Act 2010. Please note that there is a fee for this course.
