[>> Rolling out School Streets across Southwark](#)

Southwark Council is accelerating the roll-out of School Streets to create safer, healthier journeys for children across the borough. These timed closures reduce congestion and air pollution outside schools, encouraging parents and pupils to walk, cycle, scoot or use other greener ways to get to school.

>> **South London Children and Young People's Community Immunisations**

The South London Children and Young People's Community Immunisation Service (CYPCIS) deliver all school-age immunisations across south London including Southwark. Immunisations nurses provide support and advice on school age immunisations and will be able to direct to further information so parents and children can make an informed choice about planned vaccinations.

>> **Children in need: a focus on child sexual abuse and exploitation**

The Department for Education published a document that analyses the characteristics of children whose social care assessments recorded that they had been affected by child sexual abuse or sexual exploitation. It also analyses those children's journeys through social care, makes comparisons to police recorded crime data and analyses serious incident notifications data. It was commissioned in response to the [national audit on group-based child sexual exploitation and abuse](#).

>> **Inspections and beyond: supporting staff mental health and wellbeing**

As Ofsted begins inspections under its new framework, [The UK charity Education Support](#) put together a practical toolkit to help manage stress, build resilience, and support wellbeing before, during, and after inspections. It includes tools, expert tips, and guidance for a healthier school culture.
