

### Foreword by the Chair of SACRE

As a SACRE we want to ensure that the Local Authority is able to meet its statutory duties in the oversight of RE provision across the Borough. Our aim continues to ensure that the learning offer from Southwark is vibrant, relevant, and inspiring for all the young people in our schools. Part of this is the initiation of an ongoing process of reviewing the membership of SACRE to ensure that all major local religious communities (and secular alternatives) are represented. SACRE meetings continue to be engaging, and productive. All members feel that their views are considered and respected.

It is important to note that Southwark has faced immense COVID related challenges, which have not been particularly unique to inner-city London. Factors such as intergenerational living, range of housing stock, multiple community languages and digital literacy and access have all contributed to Southwark presenting with high infection rates and consequently tough restrictions. In the words of a famous writer, we have been 'afflicted in every way, but not crushed; perplexed, but not driven to despair.' Here we are again, almost two thirds of the way through another academic year and the restrictions, seemingly, almost a thing of the past. Throughout these challenging times, SACRE has continued to meet successfully once a term, digitally, via Zoom, to ensure that the planned work continues.

In Southwark, we are faced by new challenges to school funding combined with falling school roles. Primary schools have been particularly vulnerable in this respect and SACRE seeks to support all schools, whatever their circumstances, to develop high quality RE for the pupils. There is still work to be done in this area. To this end we have been trying to identify schools that may require additional support which is available through the Borough and our SACRE Advisor.

As Chair I am incredibly grateful to all who have positively embraced the new ways of meeting and demonstrated their commitment to support SACRE through these most challenging of times. We look forward, to be able to report further progress of our work in our report next year.

### 1. Introduction

Since 1988, each Local Authority (LA) has been required by law to have a Standing Advisory Council for Religious Education (SACRE).

The remit of a SACRE is principally to oversee the Religious Education (RE) and collective worship within the authority principally to:

- require Southwark Council to review the locally agreed syllabus for RE at least every five
  years. RE in community schools and foundation schools which do not have a religious
  character is to be delivered in accordance with the Agreed Syllabus;
- advise Southwark Council on teaching methods, choice of materials and teacher training in religious education and collective worship;
- advise Southwark Council upon matters connected with religious worship in community schools and in foundation schools which do not have a religious character.

It is also a requirement that each SACRE produces an annual report of its work. This report must be published and is to be sent to the LA, local schools and other interested parties.

The reporting period of the 2020-2021 report starts from September 1<sup>st</sup> 2020 and runs to August 31<sup>st</sup> 2021.

### 2. Meetings

In the academic year 2020-2021 Southwark SACRE held 3 meetings:

26<sup>th</sup> November 2020 (quorate) 18<sup>th</sup> March 2021 (quorate) 17<sup>th</sup> June 2021 (inquorate)

All meetings were held via Zoom during the reporting period.

### 3. Religious Education

Agreed Syllabus

- 3.1 RE is not part of the national curriculum. Each LA is required to produce and Agreed Syllabus for RE. Each LA is required to begin reviewing the current Agreed Syllabus within 5 years of its production.
- 3.2 Southwark's Agreed Syllabus was launched on 9<sup>th</sup> July 2018 and is now being fully followed by community schools and foundation schools that do not have a religious character.
- 3.3 No formal complaints about religious education were received this year.

- 3.4 A survey has been prepared on the teaching of the Southwark Agreed Syllabus, to be sent to schools at the start of the next academic year.
- 3.5 The resources for teachers have been refreshed on the website. Each unit for Years 1-6 now has:
  - 1 x unit plan with a front page putting the unit into context of the long-term plan
  - 1 x knowledge organiser
  - 1 x pre/post learning task.

### **Teacher Training**

3.4 Three RE Coordinators' meetings were held throughout the 2020/21 academic year. As far as possible, meetings of Subject Coordinators are planned in response to their requests and areas for development that have been identified by the adviser. The main focus of each Coordinators' meeting was as follows:

26<sup>th</sup> November 2020 – Planning for progression from the Southwark Agreed Syllabus.

18<sup>th</sup> March 2021 – Lesson ideas for RE. Focusing on those which would meet the needs of the current Agreed Syllabus.

17<sup>th</sup> June – Assessment in RE, in line with the new Agreed Syllabus.

- 3.5 During meetings, Subject Coordinators were introduced to a range of local and national initiatives and CPD, including Spirited Arts, Strictly RE and Southwark SACRE's RE competition.
- 3.6 Dog Kennell Hill and Rotherhithe Primary Schools had an online training session with the adviser on creative lesson ideas for RE.
- 3.7 Throughout the year, advice is given by telephone and email to teachers, including RE leaders and head teachers who request this.
- 3.8 Due to the increased difficulty in taking trips for RE and inviting visitors into schools, a webinar on virtual visits and visitors in RE was recorded and made available to teachers in all schools and SACRE members. It will remain online until December 2021.

### 4. Standards in Religious Education

### Introduction

4.1 With the increased number of Academies, it is difficult to ascertain the level of specialist RE teachers in Southwark schools and monitor the quality of RE. Therefore, monitoring of quality and standards of education has been done through the RE

Coordinators at the network meetings. It is also done through scrutinising the websites of schools, with SACRE members currently working to develop expertise in this area.

4.2 In general, SACRE is able to monitor standards in RE by scrutinising GCSE and A Level results. However, this year students were awarded Teacher Assessed Grades instead and SACRE has been unable to monitor these.

### 5. Collective Worship

- 5.1 A guidance document on making Collective Worship interesting and relevant is on the Southwark Schools website along with a list of trained speakers.
- 5.2 Southwark SACRE's Determinations procedure is available on request. There have been no applications for a determination (to alter the character of collective worship for some or all pupils in a school) in the reporting period.
- 5.3 There have also been no complaints concerning Collective Worship referred to SACRE during this academic year.

### 6. Other work of Southwark SACRE

- 6.1 SACRE's annual competition had the theme of 'Living Together in Harmony?'. The winner was Galleywall Primary, with Heber Primary in the 'Highly Commended' category for the musical entry from an entire Year 5 class.
- 6.2 Two members of SACRE attended this year's NASACRE conference.
- 6.3 SACRE has had a presentation on and discussed the Research Review on Religious Education, published by Ofsted.

### 7. Management of SACRE

The Council pay for 10 days for an RE Consultant to attend meetings, run a network once per term and give advice to schools. There is a representative from the Council's Education Department at every meeting and a clerk to SACRE.

Meetings have been quorate this year. SACRE has a number of vacancies and will need to increase membership.

Southwark SACRE does not have an opportunity to contribute to other agendas within the Council.
